**INVITATION TO BID FOR
CONSTRUCTION OF MULTI-PURPOSE BUILDING AT POBLACION IV, VICTORIA, ORIENTAL MINDORO**

1. The **Provincial Government of Oriental Mindoro (PGOM)**, through the **20% Development Fund 2025** intends to apply the sum of **One Million Five Hundred Ninety Six Thousand Seven Hundred Fourteen Pesos and 48/100 (Php 1,596,714.48)** being the Approved Budget for the Contract (ABC) to payments under the contract for **"Completion of Multi-Purpose Building at Poblacion IV, Victoria, Oriental Mindoro (IB No. CW-2025-076)"**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Provincial Government of Oriental Mindoro (PGOM)** now invites bids for the above Procurement Project. Completion of the Works is required **52 calendar days**. Bidders should have a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

A complete set of Bidding Documents may be acquired by interested bidders on **February 07, 2025 to February 21, 2025** from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php 5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
