The **Provincial Government of Oriental Mindoro (PGOM)** through the **20% Development Fund CA 2022** intends to apply the sum of **Two Hundred Forty Six Thousand Six Hundred Ten Pesos and 05/100 Only (Php 246,610.05)** being the approved Budget for the Contract (ABC) to payment under the contract for **“Installation of Free Flow at San Isidro, Bongabong, Or. Mindoro and Installation of Free Flow at Maragooc, Gloria, Or. Mindoro”**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PGOM now invites bids for **“Installation of Free Flow at San Isidro, Bongabong, Or. Mindoro and Installation of Free Flow at Maragooc, Gloria, Or. Mindoro”**. Completion of the Works is **15 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC.
