Concreting of Road at Papandungin, Gloria, Or. Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% Development Fund CA FY 2022 intends to apply the sum of One Million Four Hundred Ninety Eight Thousand Seven Hundred Ten Pesos and 99/100 Only (Php 1,498,710.99) being the approved Budget for the Contract (ABC) to payment under the contract for "Concreting of Road at Papandungin, Gloria, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Concreting of Road at Papandungin, Gloria, Or. Mindoro". Completion of the Works is 46 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
