Construction of Seawall at Kawit, Gloria, Or. Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% Development Fund CA 2022 intends to apply the sum of Two Million Four Hundred Ninety Five Thousand Seven Hundred Ninety Nine Pesos and 57/100 Only (Php 2,495,799.57) being the approved Budget for the Contract (ABC) to payment under the contract for "Construction of Seawall at Kawit, Gloria, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Construction of Seawall at Kawit, Gloria, Or. Mindoro". Completion of the Works is 45 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
