## INVITATION TO BID IB NO. CW 2023 - 047

### Construction of Perimeter Fence of Tennis Court at Sports Complex, Santiago, Naujan, Or. Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the General Fund CA 2021 intends to apply the sum of One Million Nine Hundred Ninety Five Thousand One Hundred Eighty Pesos and 42/100 Only (Php 1,995,180.42) being the approved Budget for the Contract (ABC) to payment under the contract for "Construction of Perimeter Fence of Tennis Court at Sports Complex, Santiago, Naujan, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Construction of Perimeter Fence of Tennis Court at Sports Complex, Santiago, Naujan, Or. Mindoro". Completion of the Works is 47 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
