Construction of Perimeter Fence of Tennis Court at Sports Complex, Santiago, Naujan, Or. Mindoro

1. The **Provincial Government of Oriental Mindoro (PGOM)** through the **General Fund CA 2021** intends to apply the sum of **One Million Nine Hundred Ninety Five Thousand One Hundred Eighty Pesos and 42/100 Only (Php 1,995,180.42)** being the approved Budget for the Contract (ABC) to payment under the contract for **“Construction of Perimeter Fence of Tennis Court at Sports Complex, Santiago, Naujan, Or. Mindoro”**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PGOM now invites bids for **“Construction of Perimeter Fence of Tennis Court at Sports Complex, Santiago, Naujan, Or. Mindoro”**. Completion of the Works is **47 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
