### Construction of Drainage Canal at Tambong, Gloria, Or. Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 5% LDRRMF CA 2022 intends to apply the sum of One Million Four Hundred Ninety Nine Thousand One Hundred Seventy Six Pesos and 52/100 Only (Php 1,499,176.52) being the approved Budget for the Contract (ABC) to payment under the contract for "Construction of Drainage Canal at Tambong, Gloria, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Construction of Drainage Canal at Tambong, Gloria, Or. Mindoro". Completion of the Works is **37 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
