### Concreting of Road at Sta. Isabel, Pinamalayan, Oriental Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% Development Fund 2023 intends to apply the sum of One Million Four Hundred Ninety Six Thousand Four Hundred Sixty Six Pesos and 57/100 (Php 1,496,466.57) being the approved Budget for the Contract (ABC) to payment under the contract for "Concreting of Road at Sta. Isabel, **Pinamalayan, Oriental Mindoro**". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Concreting of Road at Sta. Isabel, Pinamalayan, Oriental Mindoro". Completion of the Works is **38 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
