Completion of Barangay Hall at Zone I, Pola, Oriental Mindoro

1. The **Provincial Government of Oriental Mindoro (PGOM)** through the **SB No. 2 - General Fund 2023** intends to apply the sum of **One Million Eight Hundred Ninety Four Thousand Nine Hundred Sixty Two Pesos and 62/100 (Php 1,894,962.62)** being the approved Budget for the Contract (ABC) to payment under the contract for **“Completion of Barangay Hall at Zone I, Pola, Oriental Mindoro”**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PGOM now invites bids for **“Completion of Barangay Hall at Zone I, Pola, Oriental Mindoro”**. Completion of the Works is **73 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
