6. The PGOM will hold a **Pre-Bid Conference** on **September 29, 2023 at 9:00 a.m. at BAC Conference Room**, Provincial Capitol Complex, Camilmil, Calapan City, which shall be open to prospective bidders and interested parties.

7. Bids must be duly received by the BAC Secretariat, Capitol Complex, Camilmil, Calapan City, Oriental Mindoro on or before **October 13, 2023 at 8:30 a.m.** All bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Claus 18.

Bid opening shall be on **October 13, 2023 at 9:00 a.m. at BAC Conference Room, Provincial Capitol Complex, Camilmil, Calapan City, Oriental Mindoro.** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address stated. Late bids shall not be accepted.
