EXECUTIVE ORDER NO. 02 Series of 2024

AN EXECUTIVE ORDER RECONSTITUTING THE PROVINCIAL PHYSICAL FITNESS AND SPORTS DEVELOPMENT COUNCIL, PROVIDING FOR ITS DUTIES, FUNCTIONS AND OTHER PURPOSES

WHEREAS, Article XIV, Section 19 (1), of the Constitution provides that the State shall promote physical education and encourage sports program, league competitions, and amateur sports for the development of a healthy and alert citizenry.

WHEREAS, Section 7(m) of Republic Act No. 6847 also known as "The Philippine Sports Commission Act" provides that the Philippine Sports Commission (PSC) shall encourage, promote and sustain the creation and establishment of regional, provincial, municipal and barangay or school district sports promotion and development councils.

WHEREAS, Executive Order (EO) No. 63, series of 1993, directs the creation of Physical Fitness and Sports Development Council (PFSDC) in Local Government Units (LGU). The PFSDC shall act as the nationwide organizational network to assist the PSC in the planning, information dissemination, actual implementation and monitoring of the national policies and programs for sports and physical fitness.

WHEREAS, on 08 March 2011, EO No. 20, Series of 2011 was issued to reorganize the Provincial Physical Fitness and Sports Development Council (PPFSDC) of Oriental Mindoro.

WHEREAS, on 9 November 2023, the Department of the Interior and Local Government (DILG) issued Memorandum Circular (MC) No. 2023-172 to reiterate and emphasize the role of the PFSDC in LGUs.

NOW, THEREFORE, I, HUMERLITO A. DOLOR, MPA, Ph.D., by the virtue of the powers vested in me as Provincial Governor of Oriental Mindoro by Republic Act (RA) No. 7160, also known as the Local Government Code of 1991 and other pertinent laws and issuances, do hereby promulgate this Executive Order, as follows:

Section 1. Reconstituting the Provincial Physical Fitness and Sports Development Council.
The PPFSDC of Oriental Mindoro is hereby reconstituted, it shall be composed of the following:

SECTION 2. Functions. The Council shall assume the following functions and responsibilities enumerated in Section 3.1.3. of DILG MC No. 2023-172: As chair of the PPFSDC, ensure that the Council performs its roles and responsibilities, to wit:

1. Meet at least once a month and plan and formulate a blueprint for the short, medium, and long term for the sectoral sports based on the National Policy and Program of "SPORTS FOR ALL", including a well-synchronized year-round calendar of sports activities and competitions culminating in a national "PALARONG PAMBANSA"
2. Conduct local "Sports Summits" in consultation with other public and private entities concerned to identify and prioritize sports programs and activities in their respective localities and areas of concern and to monitor, review, and validate their program
3. Oversee and ensure the implementation of the physical fitness and sports program and activities
4. Disseminate proper information on the national policy and program, including their local programs to encourage the active participation of their constituents on physical fitness and sports activities;
5. Assist in the identification, recruitment, and training of gifted and talented athletes from their areas to ensure a wide base for the selection of national athletes who will represent the country in international sports competitions;
6. Submit a quarterly report to the Chairman of the National PFSDC and furnish a copy of the same to the Philippine Sports Commission; and
7. Perform other functions deemed necessary to promote and implement sports plans, programs and activities, as maybe suggested by the Chairperson.
8. Conduct annual Palarong Panlalawigan which shall feature traditional sports and disciplines included in national and international games, in coordination with the Department of Education.
9. Represent the province in inter-provincial or regional sports councils or committees, and coordinate the efforts of component cities or municipalities in the regional or national "palaro" or sports development activities.

SECTION 3. SECRETARIAT. The Governor's Office-Special Concerns Division (GO-SCD) shall be the PPFSDC's secretariat. It shall render the necessary administrative assistance and support to the council. It shall also perform the following functions:

1. Document the proceedings of the Council meetings;
2. Keep/maintain the minutes, records, and documents of the Council;
3. Set the meeting agenda and other matters pertinent to the Council meetings and other activities;
4. Prepare the Council reports; and
5. Collate data and other information essential to the formulation of the Council

SECTION 4. Funding. Funding for the operations and activities of the PPFSDC shall be sourced from the budget of the Provincial Government of Oriental Mindoro. Other sources of funds for the PPFSDC may also be secured from partnerships, grants, or donations, and other lawful funding sources.

SECTION 5. Repealing Clause. EO No. 20, Series of 2011 is hereby repealed. All executive orders, rules and regulations or parts thereof issued by Provincial Government of Oriental Mindoro which are inconsistent with this Executive Order are hereby amended, repealed and/or modified accordingly.

SECTION 6. Separability Clause. If any provision of this Executive Order is declared invalid for any reason, the parts not affected shall remain valid and in full force effect.

SECTION 7. Effectivity. This Executive Order shall be effect immediately upon its approval.
