AN EXECUTIVE ORDER REORGANIZING THE PROVINCIAL SCIENCE, TECHNOLOGY AND INNOVATION COMMITTEE DEFINING ITS FUNCTIONS, AND FOR OTHER PURPOSES

**WHEREAS**, Article XIV, Section 10 of the 1987 Philippine Constitution emphasizes the importance of science and technology in national development and progress. It provides that the State shall give priority to research, development invention, innovation, and utilization of science and technology training and services.

WHEREAS, on 4 May 2021, the MIMAROPA Regional Research, Development, and Innovation Committee (RRDIC) approved and provided guidelines for the creation of the Science, Technology and Innovation (STI) Committee in local government units;

WHEREAS, on 4 January 2022, Executive Order No. 1, 2022 was issued to establish the Provincial Science, Technology, and Innovation Committee (PSTIC) of Oriental Mindoro.

WHEREAS, there is a need to reorganize the composition of the PSTIC.

NOW, THEREFORE, I, HUMERLITO A. DOLOR, MPA, Ph.D., by virtue of the power vested in me as the Provincial Governor of Oriental Mindoro by Republic Act 7160, otherwise known as the Local Government of 1991 and other pertinent laws and issuances, do hereby promulgate this Executive Order as follows:

**SECTION 1. Reorganization.** The Provincial Science, Technology, and Innovation Committee is hereby reorganized to be composed of the following:

AN EXECUTIVE ORDER AMMENDING THE PROVINCIAL SCIENCE, TECHNOLOGY AND INNOVATION COMMITTEE FOR THE INSTITUTIONALIZATION AND IMPLEMENTATION OF STI - RELATED POLICIES AND PROGRAMS IN THE PROVINCE OF ORIENTAL MINDORO, DEFINING ITS FUNCTIONS, AND FOR OTHER PURPOSES

#### SECTION 2. Duties and Function. PSTIC shall perform the following specific functions:

- a) Develop the Science, Technology and Innovation (STI) Plan for the province;
- b) Formulate STI related programs, policies and activities and endorse the same to the Local Chief Executive and Sangguniang Panlalawigan for adoption and implementation;
- c) Strengthen the Provincial Government of Oriental Mindoro's (PGOM's) external links with other agencies and organizations to harmonize and synchronize STI efforts at various levels of governance;
- d) Ensure participation of the province's component city and municipalities in various processes related to the implementation of STI services and programs;
- e) Monitor and evaluate the STI Programs, Projects, Activities (PPA) of the province's component city/ municipalities; and
- f) Perform other functions as may be directed by pertinent laws and issuances.

SECTION 3. STI Focal Person. The Provincial Planning and Development Coordinator, EnP Lydia Muñeca S. Melgar, is hereby designated as the STI Focal Person of the PGOM. The STI Focal Person shall perform the following responsibilities:

- a. Coordinate STI related efforts of PGOM Departments, Offices, and Hospitals and advocate for the integration of STI perspectives in all of PGOM's applicable systems and processes;
- b. Monitor and facilitate the PSTIC's participation in the STI related PPAs of the national and provincial government;
- c. Collaborate and submit reports on matters relating to the programs, projects, and activities of the PSTIC; and
- d. Perform STI related functions directed by pertinent laws and issuances.

SECTION 4. Secretariat. The Provincial Planning and Development Office (PPDO) shall serve as the Secretariat of the PSTIC. The PPDO shall perform the following functions:

- a) Arrange and coordinate meetings of the PSTIC;
- b) Record all proceedings and discussions that arise from the meetings; and
- c) Perform such other tasks and functions as may be necessary.
- SECTION 5. Meetings. The PSTIC shall meet as often as maybe necessary.

**SECTION 6. Funding.** Administrative expenses of the PSTIC and the performance of the committee's functions shall be charged against the funds of the Governor's Office.

**SECTION 7. Separability Clause.** If any portion of this Executive Order is declared unconstitutional or invalid, other parts thereof which are not affected shall no continue to remain in full force and effect.

**SECTION 8. Repealing Clause.** All other executive orders, rules, and regulations, issuances, or parts thereof inconsistent with this Executive Order are hereby amended, repealed, and/or modified accordingly.

SECTION 9. Effectivity. The Executive Order shall take effect immediately upon its approval.
