AN EXECUTIVE ORDER CREATING THE EXECUTIVE COMMITTEE AND THE WORKING COMMITTEES FOR THE CELEBRATION OF FIESTA MAHAL TANA: THE 74TH FOUNDING ANNIVERSARY OF ORIENTAL MINDORO

WHEREAS, Section 79 of Provincial Ordinance No. 139-2022, otherwise known as the Provincial Tourism Code of Oriental Mindoro institutionalizes the annual celebration of Fiesta MAHAL TANA: The Oriental Mindoro Founding Anniversary to highlight the Oriental Mindoreños lively spirit of celebration and acclaim four major icons of the province: Mangyan, Halcon, Tamaraw, and Naujan Lake.

WHEREAS, on 15 November 2024, the Province of Oriental Mindoro will be celebrating its 74th Founding Anniversary.

WHEREAS, the Provincial Government spearheads the celebration done each year to commemorate our independence as a province with emphasis on our enormous achievements as people working as one for the development and progress of Oriental Mindoro.

WHEREAS, there is a need to constitute committees who shall spearhead the preparation for the celebration of Oriental Mindoro's 74th Founding Anniversary.

NOW, THEREFORE, I, HUMERLITO A. DOLOR, MPA, Ph. D., by virtue of the powers vested in me by Republic Act No. 7160 and other pertinent laws of the Republic of the Philippines as the Provincial Governor of Oriental Mindoro, do hereby promulgate this Executive Order, as follows:

SECTION 1. Date of Celebration. This year's Fiesta MAHAL TANA: The Oriental Mindoro Founding Anniversary shall be celebrated on 13-15 November 2024.

Committees, shall be charged against the available funds of the Provincial Government and other lawful sources subject to pertinent budgeting and accounting laws, rules, and regulations.

Section 8. Repealing Clause. All executive orders, rules and regulations or parts thereof issued by Provincial Government of Oriental Mindoro which are inconsistent with this Executive Order are hereby amended, repealed and/or modified accordingly.

Section 9. Separability Clause. If any portion of this Executive Order is declared unconstitutional or invalid, other parts of the provision thereof which are not affected shall continue to remain in full force and effect.

SECTION 10. Effectivity. This Executive Order shall take effect immediately upon its approval.
