## EXECUTIVE ORDER NO. 26 Series of 2024

AN EXECUTIVE ORDER CREATING THE EXECUTIVE COMMITTEE AND THE WORKING COMMITTEES FOR THE CELEBRATION OF THE SALONG DAGITAB CHRISTMAS FESTIVAL 2024 IN THE PROVINCE OF ORIENTAL MINDORO

**WHEREAS**, Article XIV, Section 14 of the 1987 Philippine Constitution provides that "the State shall foster the preservation, enrichment, and dynamic evolution of Filipino national culture based on the principle of unity in diversity in a climate of free artistic and intellectual expression."

**WHEREAS**, Section IV of the Provincial Ordinance No. 82-2018 institutionalized the Provincial Government of Oriental Mindoro's annual display of Christmas decorations and glittering lights during the Christmas Season.

WHEREAS, there is a need to constitute committees who shall spearhead the preparation and implementation of activities for the Salong Dagitab Christmas Festival 2024.

**NOW,** THEREFORE, I, HUMERLITO A. DOLOR, MPA, Ph. D., by virtue of the powers vested in me by Republic Act No. 7160 and other pertinent laws of the Republic of the Philippines as the Provincial Governor of Oriental Mindoro, do hereby promulgate this Executive Order, as follows:

**SECTION 1. Section 3. Salong Dagitab Theme. The general theme of Salong Dagitab Christmas Festival 2024 is "Animated Christmas" featuring top animated movies on Netflix, an online streaming platform, from year 2020-2024.

Section 4. Competition Guidelines and Mechanics. The Secretariat is hereby designated to draft the guidelines and mechanics which shall conduct and direct the competition.

Section 5. Funding. The expenses and other obligations of all the committees and the Secretariat shall be charged against the funds of the Provincial Government of Oriental Mindoro and other lawful sources, subject to pertinent budgeting, accounting, and auditing rules and regulations.

Section 6. Meetings. The Provincial Governor or the respective Committee Chairpersons shall call meetings as the need arises.

Section 7. Repealing Clause. All executive orders, rules and regulations or parts thereof issued by Provincial Government of Oriental Mindoro which are inconsistent with this Executive Order are hereby amended, repealed and/or modified accordingly.

Section 8. Separability Clause. If any portion of this Executive Order is declared unconstitutional or invalid, other parts of the provision thereof which are not affected shall continue to remain in full force and effect.

SECTION 9. Effectivity. This Executive Order shall take effect immediately upon its approval.
