EXECUTIVE ORDER NO. 13 Series of 2025

AN EXECUTIVE ORDER REORGANIZING THE PROVINCIAL YOUTH DEVELOPMENT COUNCIL (PYDC), PROVIDING FOR ITS FUNCTIONS, AND FOR OTHER PURPOSES

WHEREAS, Section 13 of Article II of the 1987 Constitution of the Republic of the Philippines provides that the State shall recognize the vital role of the youth in nation-building and inculcate their involvement in public and civic affairs;

WHEREAS, Sections 23 and 25 of Republic Act No. 10742, otherwise known as the Sangguniang Kabataan Reform Act of 2015, mandates the creation of a Local Youth and Development Council in every local government unit and a Provincial Youth Development Office in a province;

WHEREAS, on 21 February 2018, the Provincial Youth Development Council ("PYDC") of Oriental Mindoro was established in accordance with the foregoing laws;

WHEREAS, on 5 to 6 April 2025, assembly and election of new representatives were held;

WHEREAS, there is a need to reorganize the composition of the PYDC as a result of the said election;

NOW, **THEREFORE**, **I**, **HUMERLITO A. DOLOR**, **MPA**, **Ph. D.**, by virtue of the powers vested in me by Republic Act No. 7160 and other pertinent laws of the Republic of the Philippines as the Provincial Governor of Oriental Mindoro, do hereby promulgate this Executive Order, as follows:

Section 1. Reorganization. The PYDC of Oriental Mindoro is hereby reorganized, pursuant to the election held on 5 to 6 April 2025, to be composed of the following members whose terms will be from year 2025 to year 2028:

Section 2. Manner of Election for New Set of Representatives. Upon expiration of their terms, another assembly for election shall be conducted. Mr. Oliver Z. Almeda, the Provincial Youth Development Officer, or the designated existing personnel from the local government unit shall notify all the newly elected presidents or authorized representatives of the registered youth organizations or youth serving organizations in the province, and assemble them in a public venue for the election of the PYDC Members. Through a consensus or secret balloting, they shall elect at least eight (8) but not more than nineteen (19) representatives of the PYDC. Said representatives shall serve for a term of three (3) years in the PYDC.

Section 3. Qualifications of New PYDC Members. A succeeding PYDC Member must be a citizen of the Philippines and a resident of the province for not less than one (1) year immediately preceding the day of his/her election to the Council. He or she shall be at least fifteen (15) years of age, but not older than thirty (30) years of age. He or she must be a member of a registered youth organization or youth-serving organization. He or she must be of good moral character and must not have been convicted of any crime involving moral turpitude. No other incumbent Sangguniang Kabataan ("SK") officials, except for the President and Vice President of the SK Provincial Federation, are eligible to be members of the Council.

Section 4. Functions of the PYDC. The PYDC shall be primarily responsible in the formulation of policies of youth development programs, projects and activities in the province in coordination with various government and non-government organizations. It shall assist in the planning and execution of programs and projects of the SK and perform the following duties and functions:

a. Serve as the core advocate of youth participation in nation-building and youth empowerment;

- b. Formulate a comprehensive Provincial Youth Development Plan;
- c. Monitor and evaluate the implementation of the Provincial Youth Development Plan;
- d. Plan and operationalize the local Sentrong Pangkabataan;
- e. Facilitate the Annual Provincial Youth Parliament;
- f. Formulate and recommend policies and strategies for component programs concerning the youth in the province, in coordination with various government agencies handling youth-related programs, projects, and activities;
- g. Develop a consultative mechanism which shall provide a forum for continuous dialogue between the provincial government and the youth sector in terms of proper planning and evaluation of programs and projects affecting the youth:
- h. Discuss issues, events, and other areas of concern affecting the youth and propose or recommend solutions or necessary interventions therefor:
- i. Review existing polices, legislations, and programs intended for the youth and, if found necessary, recommend revisions thereon; and
- j. Perform such other functions as may be prescribed by law or ordinance.

Section 5. Convening of the PYDC. The duly elected President or Vice President of the SK Provincial Federation shall automatically become members of the PYDC. The Federation President or in his absence, the Vice President, shall convene the council and preside over all its meetings.

Section 6. Meetings. The PYDC shall schedule a meeting every quarter and as often as may be necessary. Subject to availability of funds, the council members shall be entitled to a reasonable honorarium for every meeting attended.

Section 7. Designation of a Provincial Youth Development Officer ("PYDO") and Assistant PYDO. A Provincial Youth Development Officer and Assistant Provincial Youth Development Officer shall be designated in accordance with Sections 26 (a), (b), and (c), Rule IV of the Implementing Rules and Regulations of Republic Act No. 10742.

Section 8. Functions of the PYDO and Assistant PYDO. The designated PYDO and Assistant PYDO shall spearhead the performance of the following functions of a Provincial Youth Development Office provided in Section 29, Rule IV and Annex B of the Implementing Rules and Regulations of Republic Act No. 10742:

- a. Register and verify youth and youth-serving organizations, subject to the Revitalized Youth Organization Registration Program Guidelines in the Provincial level;
- b. Provide technical assistance to the PYDC in the formulation of the Provincial Youth Development Plan:
- c. Facilitate the election of PYDC members in the province;
- d. Serve as Secretariat of the PYDC and provide necessary administrative, operational, staff, and technical support to the Council:
- e. Upon securing accreditation from the National Youth Commission ("NYC"), conduct mandatory and continuing training of PYDC members, in accordance with programs jointly designed and implemented by the Department of the Interior and Local Government ("DILG") and NYC;
- f. Provide technical, logistical, and other support on the conduct of other youth-related programs implemented by the DILG and NYC;

- g. Coordinate with NYC regarding youth-related projects and programs in the province;
- h. Assist the City/Municipal Youth Development Offices in the conduct of their respective SK Officer's trainings; and
- i. Perform other functions as may be prescribed by law or ordinance, or as may be required by the Provincial Governor, DILG, or the NYC.

Section 9. Funding. The funding requirements for the activities of the PYDC shall be charged against the general fund of the Governor's Office and other lawful sources subject to existing auditing rules and regulations.

Section 10. Separability Clause. If any provision of this Executive Order is declared invalid, illegal, or unconstitutional, the parts not affected shall remain valid and in full force.

Section 11. Repealing Clause. All executive orders, rules and regulations, or parts thereof issued by PGOM inconsistent with this Executive Order are hereby amended, repealed, and/or modified accordingly.

Section 12. Effectivity. This Executive Order shall take effect immediately upon its approval.
