**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND  
 RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT  
 (INFRASTRUCTURE)**

**Resolution No. 381, Series of 2025**

**WHEREAS**, there is an infrastructure project funded through the **20% Development Fund 2025** to be undertaken by the Provincial Government of Oriental Mindoro for the **Concreting of Provincial Road at Tagbakin, Pola, Oriental Mindoro (Limits:0+000.00-0+059.00; Net Length= 059.00 meters; Source: Alcate-HD+63 km-Mountainous; Road Width (m): 5.00 m; Shoulder width (m): 0.50 m (Left Side); 200(1)(t)(m): 0.20 m; 311(1)c1(t)(m):0.23 m; Stone Masonry: Sta 0+00-0+010; Lined Canal: Sta 0+00-0+059).**

**WHEREAS**, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2025-284-C) in PhilGEPS Website on **November 05, 2025** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the the **Concreting of Provincial Road at Tagbakin, Pola, Oriental Mindoro (Limits:0+000.00-0+059.00; Net Length= 059.00 meters; Source: Alcate-HD+63 km- Mountainous; Road Width (m): 5.00 m; Shoulder width (m): 0.50 m (Left Side); 200(1)(t)(m): 0.20 m; 311(1)c1(t)(m):0.23 m; Stone Masonry: Sta 0+00-0+010; Lined Canal: Sta 0+00-0+059).**

**WHEREAS**, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

**1. CMSEL CONSTRUCTION AND DEVELOPER**

**WHEREAS**, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **December 01, 2025**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as **“Government Procurement Reform Act and its Implementing Rules and Regulations”**;

**WHEREAS**, during the opening of Bid on **December 01, 2025** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

**WHEREAS**, the bid proposals submitted by **SMIB CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

**WHEREAS**, the detailed evaluation of bids conducted on **December 01, 2025** found out that bid price of **CMSEL CONSTRUCTION AND DEVELOPER** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

**WHEREAS**, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **SMIB CONSTRUCTION** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **December 9, 2025** , thereby making its bid found to be responsive;

**NOW, THEREFORE**, We the Members of the Bids and Awards Committee, in our meeting on **December 10, 2025** hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare **SMIB CONSTRUCTION** with business address at **Salong, Calapan City, Oriental Mindoro** as the bidder with **Single Calculated Responsive Bid**.
- b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with **SMIB CONSTRUCTION** for the **Concreting of Provincial Road at Tagbakin, Pola, Oriental Mindoro (Limits:0+000.00-0+059.00; Net Length= 059.00 meters; Source: Alcate-HD+63 km-Mountainous; Road Width (m): 5.00 m; Shoulder width (m): 0.50 m (Left Side); 200(1)(t)(m): 0.20 m; 311(1)c1(t)(m):0.23 m; Stone Masonry: Sta 0+00-0+010; Lined Canal: Sta 0+00-0+059)** at a contract price equivalent to **ONE MILLION ONE HUNDRED NINETY EIGHT THOUSAND THREE HUNDRED FIFTY SEVEN PESOS AND 73/100 ONLY (Php 1,198,357.73)**.
- c) To recommend to **HUMERLITO A. DOLOR**, Provincial Governor of Oriental Mindoro the approval of award and of contract to the bidder with Single Calculated Responsive Bid.


