**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
 RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
 (INFRASTRUCTURE)**

Resolution No. 382, Series of 2025

WHEREAS, there is an infrastructure project funded through the 20% DF 2025 to be undertaken by the Provincial Government of Oriental Mindoro for the **Rehabilitation of Road at Zone I, Pola, Oriental Mindoro (Limits: 0+000.00 to 0+126.00, Net Length: 126.00 meters, Road Width 1 (m): 5.00, Road Thickness (m): 0.23, Shoulder Width (m): 0.00 Both Sides, Remove & Replace of existing PCCP: Sta. 0+00-126, Source: Orconuma – HD = 53 km).**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2025-287-C) in PhilGEPS Website on **November 05, 2025** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Rehabilitation of Road at Zone I, Pola, Oriental Mindoro (Limits: 0+000.00 to 0+126.00, Net Length: 126.00 meters, Road Width 1 (m): 5.00, Road Thickness (m): 0.23, Shoulder Width (m): 0.00 Both Sides, Remove & Replace of existing PCCP: Sta. 0+00-126, Source: Orconuma – HD = 53 km).**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. SOSEP BUILDERS

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **December 01, 2025**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as **“Government Procurement Reform Act and its Implementing Rules and Regulations”**;

WHEREAS, during the opening of Bid on **December 01, 2025** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **SOSEP BUILDERS** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **December 01, 2025** found out that bid price of **SOSEP BUILDERS** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **SOSEP BUILDERS** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **December 9, 2025** , thereby making its bid found to be responsive;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on **December 10, 2025** hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare **SOSEP BUILDERS** with business address at **Campaasan, Bulalacao, Oriental Mindoro** as the bidder with **Single Calculated Responsive Bid**.
- b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with **SOSEP BUILDERS** for the **Rehabilitation of Road at Zone I, Pola, Oriental Mindoro (Limits: 0+000.00 to 0+126.00, Net Length: 126.00 meters, Road Width 1 (m): 5.00, Road Thickness (m): 0.23, Shoulder Width (m): 0.00 Both Sides, Remove & Replace of existing PCCP: Sta. 0+00-126, Source: Orconuma – HD = 53 km)** at a contract price equivalent to **ONE MILLION ONE HUNDRED NINETY EIGHT THOUSAND ONE HUNDRED NINETY THREE PESOS AND 30/100 ONLY (Php 1,198,193.30)**.
- c) To recommend to **HUMERLITO A. DOLOR**, Provincial Governor of Oriental Mindoro the approval of award and of contract to the bidder with Single Calculated Responsive Bid.
