CONTRACT AGREEMENT


THIS AGREEMENT, made this 26 AUG 2025 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **MARTINEZ ENTERPRISES** with office address at Lumangbayan, Calapan City, Oriental Mindoro represented by **LYN A. MARTINEZ**, Proprietress, hereinafter called the "CONTRACTOR".


WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Concreting of Provincial Road at Bacungan, Pola, Oriental Mindoro** hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **ONE MILLION ONE HUNDRED SEVENTY EIGHT THOUSAND THIRTY THREE PESOS AND 28/100 ONLY (Php 1,178,033.28)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 9. Approve Budget for the Contract
 - B. Bid Form including its Eligibility/Technical Proposals and Financial Proposals, with addendum showing corrections, if any, made during the Bid Evaluation to arrive at the Calculated Bid.
 - C. Notice of Award of Contract and the Contractor's "Conforme" thereon.
 - D. Performance Security
 - E. Credit Line or Net Financial Contracting Capacity.
 - F. PERT/CPM Diagram and bar chart with S-curve.
 - G. Other documentary requirements
 1. Equipment Utilization Schedule
 2. Manpower Utilization Schedule
 3. Construction Method
 4. Construction Schedule and S-Curve
 5. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the contract.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.


