BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT (INFRASTRUCTURE)

Resolution No. 376, Series of 2025

WHEREAS, there is an infrastructure project funded through the **20% DF 2025** to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Water System at Sinandigan, Puerto Galera, Oriental Mindoro (Project Description: Drilling & Installation of Deepwell Pipe Casing (7 pcs- 5" G.I Pipe, S40 including perforated G.I. Casing), 1000 L Cap. Stainless Tank, Installation of 1.5 HP Submersible Pump, 3 units electric post with concrete pedestal).**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2025-336-B) in PhilGEPS Website on **November 07, 2025** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Construction of Water System at Sinandigan, Puerto Galera, Oriental Mindoro (Project Description: Drilling & Installation of Deepwell Pipe Casing (7 pcs- 5" G.I Pipe, S40 including perforated G.I. Casing), 1000 L Cap. Stainless Tank, Installation of 1.5 HP Submersible Pump, 3 units electric post with concrete pedestal).**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. SOSEP BUILDERS

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **November 17, 2025**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as **"Government Procurement Reform Act and its Implementing Rules and Regulations"**;

WHEREAS, during the opening of Bid on **November 17, 2025** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **SOSEP BUILDERS** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **September 12, 2025** found out that bid price of **D. SOSEP BUILDERS** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **SOSEP BUILDERS** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **November 21, 2025**, thereby making its bid found to be responsive;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on **November 24, 2025** hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare **SOSEP BUILDERS** with business address at **Campaasan, Bulalacao, Oriental Mindoro** as the bidder with **Single Calculated Responsive Bid**.
- b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with **SOSEP BUILDERS** for the **Construction of Water System at Sinandigan, Puerto Galera, Oriental Mindoro (Project Description: Drilling & Installation of Deepwell Pipe Casing (7 pcs- 5" G.I Pipe, S40 including perforated G.I. Casing), 1000 L Cap. Stainless Tank, Installation of 1.5 HP Submersible Pump, 3 units electric post with concrete pedestal** at a contract price equivalent to **NINE HUNDRED NINETY EIGHT THOUSAND FOUR HUNDRED SEVENTEEN PESOS and 59/100 ONLY (Php 998,417.59)**.
- c) To recommend to **HUMERLITO A. DOLOR**, Provincial Governor of Oriental Mindoro the approval of award and of contract to the bidder with Single Calculated Responsive Bid.


