**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT (INFRASTRUCTURE)**

**Resolution No. 396, Series of 2025**

**WHEREAS**, there is an infrastructure project funded through the **20% Development Fund** to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Water System at Pahilahan, Pola (Source: Alcate, Victoria, Project Description: Installation of Single Phase Line Extension & Distributor Transformer 25kVa Installation of Submersible Deep Well Pump Rehabilitation of Collection Box and Pumphouse Roofing, Total Length of Pipes: 2"ØHDPE Pipe SDR11 = 240m).**

**WHEREAS**, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2025-374) in PhilGEPS Website on **November 07, 2025** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Construction of Water System at Pahilahan, Pola (Source: Alcate, Victoria, Project Description: Installation of Single Phase Line Extension & Distributor Transformer 25kVa Installation of Submersible Deep Well Pump Rehabilitation of Collection Box and Pumphouse Roofing, Total Length of Pipes: 2"ØHDPE Pipe SDR11 = 240m).**

**WHEREAS**, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

**1. MARCING CONSTRUCTION SERVICES**

**WHEREAS**, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **December 01, 2025**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

**WHEREAS**, during the opening of Bid on **December 01, 2025** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

**WHEREAS**, the bid proposals submitted by **MARCING CONSTRUCTION SERVICES** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

**WHEREAS**, the detailed evaluation of bids conducted on **December 01, 2025** found out that bid price of **MARCING CONSTRUCTION SERVICES** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

**WHEREAS**, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **MARCING CONSTRUCTION SERVICES** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **December 9, 2025** thereby making its bid found to be responsive;

**NOW, THEREFORE**, We the Members of the Bids and Awards Committee, in our meeting on **December 10, 2025** hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare **MARCING CONSTRUCTION SERVICES** with business address at **National Highway, Calapan City, Oriental Mindoro** as the bidder with **Single Calculated Responsive Bid**.
- b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with **MARCING CONSTRUCTION SERVICES** for the **Construction of Water System at Pahilahan, Pola (Source: Alcate, Victoria, Project Description: Installation of Single Phase Line Extension & Distributor Transformer 25kVa Installation of Submersible Deep Well Pump Rehabilitation of Collection Box and Pumphouse Roofing, Total Length of Pipes: 2"ØHDPE Pipe SDR11 = 240m)** at a contract price equivalent to **ONE MILLION ONE HUNDRED NINETY SEVEN THOUSAND PESOS AND 30/100 ONLY (Php 1,197,000.30)**.
- c) To recommend to **HUMERLITO A. DOLOR**, Provincial Governor of Oriental Mindoro the approval of award and of contract to the bidder with **Single Calculated Responsive Bid**.
