**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
 RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
 (INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the **SB No. 3 - 20% DF 2025** to be undertaken by the Provincial Government of Oriental Mindoro for the **Concreting of Road at Sto. Niño, Puerto Galera, Oriental Mindoro (Limits: L1=0+000.00- 0+005.00; L2=0+000.00 – 0+123.00, Net Length 1=5.00m ; Length2 =123.00m, Length 1 (0+000.00 -0+005.000), Road Width (m): 4.00 m, Shoulder: 0.00 m B/s, 200(1)(t) (m) 0.20 m, 311(1)(t) (m): 0.23 m, Length of PCCP: 005.00 meters, Length 2a (0+000.00 -0+036.000), Road Width (m): 4.00 m, Shoulder: 0.00 m B/s, 200(1)(t) (m): 0.20 m, 311 (1) (t) (m): 0.23m, Length of PCCP: 036.00 meters, Length 2b (0+036.00 -0+123.00), Road Width (m) 4.00 m, Shoulder: 0.50 m B/s, 200(1)(t) (m): 0.20 m, 311(1)(t) (m): 0.23 m, Length of PCCP: 087.00 meters, Source Aggregates ; Tigkan, Naujan).**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2025-298-A) in PhilGEPS Website on **July 18, 2025** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for **Concreting of Road at Sto. Niño, Puerto Galera, Oriental Mindoro (Limits: L1=0+000.00- 0+005.00; L2=0+000.00 – 0+123.00, Net Length 1=5.00m ; Length2 =123.00m, Length 1 (0+000.00 -0+005.000), Road Width (m): 4.00 m, Shoulder: 0.00 m B/s, 200(1)(t) (m) 0.20 m, 311(1)(t) (m): 0.23 m, Length of PCCP: 005.00 meters, Length 2a (0+000.00 -0+036.000), Road Width (m): 4.00 m, Shoulder: 0.00 m B/s, 200(1)(t) (m): 0.20 m, 311 (1) (t) (m): 0.23m, Length of PCCP: 036.00 meters, Length 2b (0+036.00 -0+123.00), Road Width (m) 4.00 m, Shoulder: 0.50 m B/s, 200(1)(t) (m): 0.20 m, 311(1)(t) (m): 0.23 m, Length of PCCP: 087.00 meters, Source Aggregates ; Tigkan, Naujan).**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. RADEL CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Conference Room, Provincial Capitol Complex, Calapan City on **August 11, 2025**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as **“Government Procurement Reform Act and its Implementing Rules and Regulations”**;

WHEREAS, during the opening of Bid on **August 11, 2025** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **RADEL CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **August 11, 2025** found out that bid price of **RADEL CONSTRUCTION** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **RADEL CONSTRUCTION** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **August 20, 2025**, thereby making its bid found to be responsive;


NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on **August 22, 2025** hereby **RESOLVE**, as it is hereby **RESOLVED**:


- a) To declare **RADEL CONSTRUCTION** with business address at **Along C-5 Road, Sta. Isabel, Calapan City, Oriental** as the bidder with **Single Calculated Responsive Bid**.
- b) recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with **RADEL CONSTRUCTION** for the **Concreting of Road at Sto. Niño, Puerto Galera, Oriental Mindoro (Limits: L1=0+000.00- 0+005.00; L2=0+000.00 – 0+123.00, Net Length 1=5.00m ; Length2 =123.00m, Length 1 (0+000.00 -0+005.000), Road Width (m): 4.00 m, Shoulder: 0.00 m B/s, 200(1)(t) (m) 0.20 m, 311(1)(t) (m): 0.23 m, Length of PCCP: 005.00 meters, Length 2a (0+000.00 -0+036.000), Road Width (m): 4.00 m, Shoulder: 0.00 m B/s, 200(1)(t) (m): 0.20 m, 311 (1) (t) (m): 0.23m, Length of PCCP: 036.00 meters, Length 2b (0+036.00 -0+123.00), Road Width (m) 4.00 m,**

Shoulder: 0.50 m B/s, 200(1)(t) (m): 0.20 m, 311(1)(t) (m): 0.23 m, Length of PCCP: 087.00 meters, Source Aggregates ; Tigkan, Naujan). at a contract price equivalent to ONE MILLION NINETY SEVEN THOUSAND NINE HUNDRED EIGHTY SIX PESOS and 80/100 ONLY (Php 1,097,986.80).

- c) To recommend to **HUMERLITO A. DOLOR**, Provincial Governor of Oriental Mindoro the approval of award and of contract to the bidder with Single Calculated Responsive Bid.
