CONTRACT AGREEMENT

THIS AGREEMENT, made this 19 DEC 2025 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **SOSEP BUILDERS** with office address at Campaasan, Bulalacao, Oriental Mindoro represented by **ERNESTO C. VILLAS JR.**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Concreting of Provincial Road at Sto. Niño, Pinamalayan, Oriental Mindoro** hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **ONE MILLION TWO HUNDRED NINETY SIX THOUSAND TWO HUNDRED NINETY PESOS AND 20/100 ONLY (Php 1,296,290.20)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
