BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT (INFRASTRUCTURE)

Resolution No. 384, Series of 2025

WHEREAS, there is an infrastructure project funded through the **20% DF 2025** to be undertaken by the Provincial Government of Oriental Mindoro for the **Concreting of Provincial Road at Sto. Niño, Pinamalayan, Oriental Mindoro (Limits: 0+000.00 to 0+136.00: Net Length: 136.00 meters, Source: ALCATE – HD = 48 km; Length: 136.00: Road Width(m) 4.00m; Shoulder width (m) 0.50 m(Both Side); 200 (1)(t)(m); 311(1)c1(t)(m); 0.23 m; SLOPE PROTECTION (Grouted Riprap Class “A”): Sta. 0+013.5 – 0+47.5 (Remove & Replaced @ R/S, Sta. 0+0120-0+136 @ R/S).**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2025-321-A) in PhilGEPS Website on **November 05, 2025** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Concreting of Provincial Road at Sto. Niño, Pinamalayan, Oriental Mindoro (Limits: 0+000.00 to 0+136.00: Net Length: 136.00 meters, Source: ALCATE – HD = 48 km; Length: 136.00: Road Width(m) 4.00m; Shoulder width (m) 0.50 m(Both Side); 200 (1)(t)(m); 311(1)c1(t)(m); 0.23 m; SLOPE PROTECTION (Grouted Riprap Class “A”): Sta. 0+013.5 – 0+47.5 (Remove & Replaced @ R/S, Sta. 0+0120-0+136 @ R/S).**

WHEREAS, in response to the said advertisement, **Two (2) prospective bidders/contractors** submitted application for eligibility and purchased bid documents;

1. **SOSEP BUILDERS**
2. **HJP CONSTRUCTION CORP.**

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **December 01, 2025**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as **“Government Procurement Reform Act and its Implementing Rules and Regulations”**;

WHEREAS, during the opening of Bid on **December 1, 2025** eligibility check were conducted to two (2) bidders/contractors mentioned above and the bid of **HJP CONSTRUCTION CORP.**, submitted expired PCAB license making it's bid automatically disqualified;

WHEREAS, the bid proposals submitted by **SOSEP BUILDERS** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **December 01, 2025** found out that bid price of **SOSEP BUILDERS** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **SOSEP BUILDERS** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **December 9, 2025** , thereby making its bid found to be responsive;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on **December 10, 2025** hereby **RESOLVE**, as it is hereby **RESOLVED**:


- a) To declare **SOSEP BUILDERS** with business address at **Campaasan, Bulalacao, Oriental Mindoro** as the bidder with **Single Calculated Responsive Bid**.
- b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with **SOSEP BUILDERS** for the **Concreting of Provincial Road at Sto. Niño, Pinamalayan, Oriental Mindoro (Limits: 0+000.00 to 0+136.00: Net Length: 136.00 meters, Source: ALCATE – HD = 48 km; Length: 136.00: Road Width(m) 4.00m; Shoulder width (m) 0.50 m(Both Side); 200 (1)(t)(m); 311(1)c1(t)(m); 0.23 m; SLOPE PROTECTION (Grouted Riprap Class “A”): Sta. 0+013.5 – 0+47.5 (Remove & Replaced @ R/S, Sta. 0+0120-0+136 @ R/S) at a contract price equivalent to ONE MILLION FOUR HUNDRED NINETY SEVEN THOUSAND SIX HUNDRED EIGHTEEN PESOS AND 61/100 ONLY (Php 1,497,618.61).**

c) To recommend to **HUMERLITO A. DOLOR**, Provincial Governor of Oriental Mindoro the approval of award and of contract to the bidder with Single Calculated Responsive Bid.
