CONTRACT AGREEMENT

THIS AGREEMENT, made this 18 SEP 2025 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **SOSEP BUILDERS** with office address at Campaasan, Bulalacao, Oriental Mindoro represented by **ERNESTO C. VILLAS JR.**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the, **Rehabilitation of Multi-Purpose Building at Wawa, Pinamalayan, Oriental Mindoro** hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **SIX HUNDRED NINETY TWO THOUSAND EIGHTY SEVEN PESOS AND 24/100 ONLY (Php 692,087.24)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


