**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
 RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
 (INFRASTRUCTURE)**

Resolution No. 348, Series of 2025

WHEREAS, there is an infrastructure project funded through the 5% LDRRMF 2025 to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Drainage Canal at Lazareto, Calapan City, Oriental Mindoro (Limits: Canal (Closed): Sta. 0+000.00 - Sta.0 + 091.00(L/S), Net Length: 091.00 meters, Canal (Closed): Sta. 0+000.00 - Sta.0 + 091.00(L/S), L=91.00 m(Left Side), W= 0.7m(Inside), D(Invert)= 1.4 m(Average), Total Length= 91.00 m).**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2025-345) in PhilGEPS Website on **August 25, 2025** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Construction of Drainage Canal at Lazareto, Calapan City, Oriental Mindoro (Limits: Canal (Closed): Sta. 0+000.00 - Sta.0 + 091.00(L/S), Net Length: 091.00 meters, Canal (Closed): Sta. 0+000.00 - Sta.0 + 091.00(L/S), L=91.00 m(Left Side), W= 0.7m(Inside), D(Invert)= 1.4 m(Average), Total Length= 91.00 m).**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. NINE EIGHT CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **September 03, 2025**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as **“Government Procurement Reform Act and its Implementing Rules and Regulations”**;

WHEREAS, during the opening of Bid on **September 03, 2025** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **NINE EIGHT CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **September 03, 2025** found out that bid price of **NINE EIGHT CONSTRUCTION** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **NINE EIGHT CONSTRUCTION** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **September 10, 2025** , thereby making its bid found to be responsive;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on **September 12, 2025** hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare **NINE EIGHT CONSTRUCTION** with business address at **Barangay Malad, Calapan City, Oriental Mindoro** as the bidder with **Single Calculated Responsive Bid**.
- b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with **NINE EIGHT CONSTRUCTION** for the **Construction of Drainage Canal at Lazareto, Calapan City, Oriental Mindoro (Limits: Canal (Closed): Sta. 0+000.00 - Sta.0 + 091.00(L/S), Net Length: 091.00 meters, Canal (Closed): Sta. 0+000.00 - Sta.0 + 091.00(L/S), L=91.00 m(Left Side), W= 0.7m(Inside), D(Invert)= 1.4 m(Average), Total Length= 91.00 m)** at a contract price equivalent to **NINE HUNDRED NINETY SEVEN THOUSAND THREE HUNDRED FIFTEEN PESOS AND 26/100 ONLY (Php 997,315.26)**.
- c) To recommend to **HUMERLITO A. DOLOR**, Provincial Governor of Oriental Mindoro the approval of award and of contract to the bidder with **Single Calculated Responsive Bid**.




