**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
 RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
 (INFRASTRUCTURE)**

Resolution No. 349, Series of 2025

WHEREAS, there is an infrastructure project funded through the 20% DF 2025 to be undertaken by the Provincial Government of Oriental Mindoro for the **Concreting of Road at Aplaya, Bongabong, Oriental Mindoro (Limits: L1 = 146.50 m; L2 = 82.3m, Net Length: 228.80 meters, source: Alcate-HD = 17 km, Road Width (m) 3.00, Shoulder width (m): 0.00 m (Both Side), 200(1) (t) (m): 0.20 m, 311(1)a(t) (m): 0.15 m, Remove & replace: Length 2-82.3mx3m).**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2025-347) in PhilGEPS Website on **August 25, 2025** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Concreting of Road at Aplaya, Bongabong, Oriental Mindoro (Limits: L1 = 146.50 m; L2 = 82.3m, Net Length: 228.80 meters, source: Alcate-HD = 17 km, Road Width (m) 3.00, Shoulder width (m): 0.00 m (Both Side), 200(1) (t) (m): 0.20 m, 311(1)a(t) (m): 0.15 m, Remove & replace: Length 2-82.3mx3m).**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. MHARPHY CONSTRUCTION AND SUPPLY

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **September 03, 2025**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as **“Government Procurement Reform Act and its Implementing Rules and Regulations”**;

WHEREAS, during the opening of Bid on **September 03, 2025** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **MHARPHY CONSTRUCTION AND SUPPLY** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **September 03, 2025** found out that bid price of **NINE EIGHT CONSTRUCTION** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **MHARPHY CONSTRUCTION AND SUPPLY** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **September 10, 2025** , thereby making its bid found to be responsive;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on **September 12, 2025** hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare **MHARPHY CONSTRUCTION AND SUPPLY** with business address at **San Aquilino, Roxas, Oriental Mindoro** as the bidder with **Single Calculated Responsive Bid**.
- b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with **MHARPHY CONSTRUCTION AND SUPPLY** for the **Concreting of Road at Aplaya, Bongabong, Oriental Mindoro (Limits: L1 = 146.50 m; L2 = 82.3m, Net Length: 228.80 meters, source: Alcate-HD = 17 km, Road Width (m) 3.00, Shoulder width (m): 0.00 m (Both Side), 200(1) (t) (m): 0.20 m, 311(1)a(t) (m): 0.15 m, Remove & replace: Length 2-82.3mx3m)** at a contract price equivalent to **EIGHT HUNDRED SEVENTY NINE THOUSAND TWO HUNDRED TWENTY FOUR PESOS AND 22/100 ONLY (Php 879,244.22).**

c) To recommend to **HUMERLITO A. DOLOR**, Provincial Governor of Oriental Mindoro the approval of award and of contract to the bidder with Single Calculated Responsive Bid.
