**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
 RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
 (INFRASTRUCTURE)**

Resolution No. 281, Series of 2025

WHEREAS, there is an infrastructure project funded through the **SB - 3 20% DF 2025** to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Senior Citizen’s Building at San Juan, Bongabong, Oriental Mindoro (Total Area: 8.50 m x 7.20m (including porch), Source: Orconuma, Type of Building: Senior Citizen, Auxiliary Structures: Construction of 7.20m x 8.50m (Including porch) Senior Citizen’s Building w/ Concrete Signage, Window Grills and Cabinets).**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2025-292-A) in PhilGEPS Website on **July 18, 2025** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for **Construction of Senior Citizen’s Building at San Juan, Bongabong, Oriental Mindoro (Total Area: 8.50 m x 7.20m (including porch), Source: Orconuma, Type of Building: Senior Citizen, Auxiliary Structures: Construction of 7.20m x 8.50m (Including porch) Senior Citizen’s Building w/ Concrete Signage, Window Grills and Cabinets).**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. D. PANOPIO CONSTRUCTION SERVICES

WHEREAS, the opening of bid was held at BAC Conference Room, Provincial Capitol Complex, Calapan City on **August 11, 2025**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as **“Government Procurement Reform Act and its Implementing Rules and Regulations”**;

WHEREAS, during the opening of Bid on **August 11, 2025** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **D. PANOPIO CONSTRUCTION SERVICES** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **August 11, 2025** found out that bid price of **D. PANOPIO CONSTRUCTION SERVICES** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **D. PANOPIO CONSTRUCTION SERVICES** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **August 20, 2025**, thereby making its bid found to be responsive;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on **August 22, 2025** hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare **D. PANOPIO CONSTRUCTION SERVICES** with business address at **Tawagan, Calapan City, Oriental** as the bidder with **Single Calculated Responsive Bid**.
- b) recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with **D. PANOPIO CONSTRUCTION SERVICES** for the **Construction of Senior Citizen’s Building at San Juan, Bongabong, Oriental Mindoro (Total Area: 8.50 m x 7.20m (including porch), Source: Orconuma, Type of Building: Senior Citizen, Auxiliary Structures: Construction of 7.20m x 8.50m (Including porch) Senior Citizen’s Building w/ Concrete Signage, Window Grills and Cabinets).** at a contract price equivalent to **ONE MILLION FIVE HUNDRED NINETY FIVE THOUSAND SEVEN HUNDRED THIRTY NINE PESOS and 45/100 ONLY (Php 1,595,739.45).**

- c) To recommend to **HUMERLITO A. DOLOR**, Provincial Governor of Oriental Mindoro the approval of award and of contract to the bidder with Single Calculated Responsive Bid.
