BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT (INFRASTRUCTURE)

Resolution No. 299, Series of 2025

WHEREAS, there is an infrastructure project funded through the 20% DF 2025 to be undertaken by the Provincial Government of Oriental Mindoro for the **Concreting of the Provincial Road at Labonan, Bongabong, Oriental Mindoro (Limits: L1 = Sta. 0+000 – 0+122, L2 = Sta. 0+000 – 0+060, Net Length: 182.00 meters, Source Orconuma – HD = 2.4 km Minimum, Length 1: 122 m w/ existing PCCP x 4m, Road Width (m) : 4.00 m, Shoulder width (m): 1.00 m (Both Side), 200(1) (t) (m) 0.20 m, 311(1)c1(t) (m): 0.23 m, Length 2: 60 m x 3m w/ o shoulder B/S, 200(1) (t) (m): 0.20 m: 311(1)c1(t) (m): 0.15 m, Cross Drain: Station 0+002 @ Length 2).**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2025-310-A) in PhilGEPS Website on **July 23, 2025** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Road at Labonan, Bongabong, Oriental Mindoro (Limits: L1 = Sta. 0+000 – 0+122, L2 = Sta. 0+000 – 0+060, Net Length: 182.00 meters, Source Orconuma – HD = 2.4 km Minimum, Length 1: 122 m w/ existing PCCP x 4m, Road Width (m) : 4.00 m, Shoulder width (m): 1.00 m (Both Side), 200(1) (t) (m) 0.20 m, 311(1)c1(t) (m): 0.23 m, Length 2: 60 m x 3m w/ o shoulder B/S, 200(1) (t) (m): 0.20 m: 311(1)c1(t) (m): 0.15 m, Cross Drain: Station 0+002 @ Length 2).**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. A.D.L CONSTRAK OPC

WHEREAS, the opening of bid was held at BAC Conference Room, Provincial Capitol Complex, Calapan City on **August 13, 2025**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as **“Government Procurement Reform Act and its Implementing Rules and Regulations”**;

WHEREAS, during the opening of Bid on **August 13, 2025** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **A.D.L CONSTRAK OPC** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **August 13, 2025** found out that bid price of **A.D.L CONSTRAK OPC** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **A.D.L CONSTRAK OPC** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **August 22, 2025**, thereby making its bid found to be responsive;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on **August 26, 2025** hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare **A.D.L CONSTRAK OPC** with business address at **FGY Street Sta. Fe Bagumbayan, Roxas, Oriental Mindoro**, as the bidder with **Single Calculated Responsive Bid**.
- b) recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with **A.D.L CONSTRAK OPC** for the **Road at Labonan, Bongabong, Oriental Mindoro (Limits: L1 = Sta. 0+000 – 0+122, L2 = Sta. 0+000 – 0+060, Net Length: 182.00 meters, Source Orconuma – HD = 2.4 km Minimum, Length 1: 122 m w/ existing PCCP x 4m, Road Width (m) : 4.00 m, Shoulder width (m): 1.00 m (Both Side), 200(1) (t) (m) 0.20 m, 311(1)c1(t) (m): 0.23 m, Length 2: 60 m x 3m w/ o shoulder B/S, 200(1) (t) (m): 0.20 m: 311(1)c1(t) (m): 0.15 m, Cross Drain: Station 0+002 @ Length 2)** at a contract price equivalent to **ONE MILLION ONE HUNDRED NINETY FIVE THOUSAND PESOS ONLY (Php 1,195,000.00)**.

- c) To recommend to **HUMERLITO A. DOLOR**, Provincial Governor of Oriental Mindoro the approval of award and of contract to the bidder with Single Calculated Responsive Bid.
