**INVITATION TO BID FOR**  
**CONSTRUCTION OF 1 STOREY, 2 CLASSROOMS AT LUMANGBAYAN NATIONAL HIGH SCHOOL, LUMANGBAYAN, BACO,**  
**ORIENTAL MINDORO**

1. The **Provincial Government of Oriental Mindoro (PGOM)**, through the **SIP MOA 2026** intends to apply the sum of **Five Million Three Hundred Ninety Four Thousand Four Hundred Thirty Pesos and 24/100 (Php 5,394,430.24)** being the Approved Budget for the Contract (ABC) to payments under the contract for **“Construction of 1 Storey, 2 Classrooms at Lumangbayan National Highschool, Lumangbayan, Baco, Oriental Mindoro (IB No. CW-2026-028)”**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The **Provincial Government of Oriental Mindoro (PGOM)** now invites bids for the above Procurement Project. Completion of the Works is required **167 calendar days**. Bidders should have a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested Bidders may obtain further information from Bids and Awards Committee of the PGOM and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M. of Mondays to Fridays.

The PGOM will hold a **Pre-Procurement Conference on April 27, 2026 at 9:00 a.m. at BAC Conference Room, Provincial Capitol Complex, Camilmil, Calapan City, Oriental Mindoro** which shall be open to prospective bidders.

5. A complete set of Bidding Documents may be acquired by interested bidders on **May 05, 2026 to May 19, 2026** from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos (Php 10,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.

6. The PGOM will hold a **Pre-Bid Conference on May 05, 2026 at 9:00 a.m. at BAC Conference Room, Provincial Capitol Complex, Camilmil, Calapan City, Oriental Mindoro** which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before **May 19, 2026 at 8:30 a.m.** Late Bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.

9. Bid opening shall be on **May 19, 2026 at 9:00 a.m. at BAC Conference Room, Provincial Capitol Complex, Camilmil, Calapan City, Oriental Mindoro**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the activity.

The PGOM reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
