**Resolution No. 066, Series of 2021**

**WHEREAS**, there is a purchase request submitted to the BAC for the procurement of **Supply & Delivery of General Merchandise for use in the Salong Dagitab at Calapan City, Oriental Mindoro;**

**WHEREAS**, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. GS-2021-068) in PhilGEPS Website on **November 3, 2021** and posted in the Provincial Capitol Complex, Bulletin Board Camilmil, Calapan City on even date for the **Supply & Delivery of General Merchandise for use in the Salong Dagitab at Calapan City, Oriental Mindoro;**

**WHEREAS**, the pre-bid conference conducted on **November 11, 2021 at 10:00 a.m.** was attended by the prospective bidders, BAC Members and BAC Secretariat in which the bidders were given the opportunity to clarify the eligibility, technical and financial components of the contract to be bid;

**WHEREAS**, in response to the said advertisement, **one (1) prospective bidder** purchased corresponding bid documents;

**WHEREAS**, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City at **10:00 a.m of November 23, 2021**, the proceeding was in accordance with the provisions of **R.A. 9184** otherwise known as **"Government Procurement Reform Act and its Implementing Rules and Regulations"**;

**WHEREAS**, all bids were examined and found substantially complied with the technical and financial proposals, thereby making all bids passed the preliminary examination with their bid price as read shown hereunder;

**WHEREAS**, the detailed evaluation and comparison of bids conducted on **November 23, 2021** found that the bid price of **MKRJ MARKETING** is deemed the most advantageous to the government, no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Responsive Bid;**

WHEREAS, upon careful examination, validation and verification of eligibility, technical and financial requirements submitted by MKRJ MARKETING with **Single Calculated Responsive Bid**, its bid passed the post qualification process conducted on **November 26, 2021**, thereby making its bid responsive;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, in our meeting on **November 29, 2021** hereby **RESOLVE**, as it is hereby **RESOLVED**:

a) To declare MKRJ MARKETING with business address at **San Agustin I, Naujan Oriental Mindoro** as the bidder with the **Single Calculated Responsive Bid**.

b) To recommend that the Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with MKRJ MARKETING for the **Supply & Delivery of General Merchandise for use of Salong Dagitab at Calapan City, Oriental Mindoro** at a contract price equivalent to **ONE MILLION SIX HUNDRED FOURTEEN THOUSAND SEVENTY NINE PESOS AND 25/100 ONLY (Php 1,614,079.25)**; and

UNANIMOUSLY APPROVED.


