WHEREAS, all bids were examined and found substantially complied with the technical and financial proposals, thereby making all bids passed the preliminary examination with their bid price as read shown hereunder;

  - c) To recommend to HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor of Oriental Mindoro the approval of the award and contract to the bidder with the Single Calculated Responsive Bid.
