WHEREAS, there is a purchase request submitted to the BAC for the procurement of **Supply & Delivery of Hospital/Medial Equipment for the Molecular Laboratory of OMSDH;**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. GS-2021-073) in PhilGEPS Website on **November 25, 2021** and posted in the Provincial Capitol Complex, Bulletin Board Camilmil, Calapan City on even date for the **Supply & Delivery of Hospital/Medial Equipment for the Molecular Laboratory of OMSDH;**

WHEREAS, the pre-bid conference conducted on **December 2, 2021 at 10:00 a.m.** was attended by the prospective bidders, BAC Members and BAC Secretariat in which the bidders were given the opportunity to clarify the eligibility, technical and financial components of the contract to be bid;

WHEREAS, in response to the said advertisement, **one (1) prospective bidder** purchased corresponding bid documents;

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City at **10:00 a.m of December 14, 2021**, the proceeding was in accordance with the provisions of **R.A. 9184** otherwise known as **"Government Procurement Reform Act and its Implementing Rules and Regulations"**;

WHEREAS, all bids were examined and found substantially complied with the technical and financial proposals, thereby making all bids passed the preliminary examination with their bid price as read shown hereunder;

WHEREAS, the detailed evaluation and comparison of bids conducted on **December 14, 2021** found that the bid price of **TOUCHSTAR ENTERPRISES** is deemed the most advantageous to the government, no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Responsive Bid;**

WHEREAS, upon careful examination, validation and verification of eligibility, technical and financial requirements submitted by **TOUCHSTAR ENTERPRISES** with **Single Calculated Responsive Bid**, its bid passed the post qualification process conducted on **December 16, 2021**, thereby making its bid responsive;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, in our meeting on **December 20, 2021** hereby **RESOLVE**, as it is hereby **RESOLVED**:

a) To declare **TOUCHSTAR ENTERPRISES** with business address at **1116 D. Dagonoy St. Singalong Manila** as the bidder with the **Single Calculated Responsive Bid**.

b) To recommend that the Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with **TOUCHSTAR ENTERPRISES** for the **Supply & Delivery of Hospital/Medial Equipment for the Molecular Laboratory of OMSDH** at a contract price equivalent to **THREE MILLION NINE HUNDRED NINETY EIGHT THOUSAND SIX HUNDRED FIFTY NINE PESOS ONLY (Php 3,998,659.00)**; and
