WHEREAS, there is a purchase request submitted to the BAC for the procurement of **Supply & Delivery of Printing Services for use of PPDO re PDPFP Reproduction;**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. GS-2021-107) in PhilGEPs Website on **August 3, 2021** and posted in the Provincial Capitol Complex, Bulletin Board Camilmil, Calapan City on even date for the **Supply & Delivery of Printing Services for use of PPDO re PDPFP Reproduction;**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder** purchased corresponding bid documents;

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City at **2:00 p.m of August 10, 2021**, the proceeding was in accordance with the provisions of **R.A. 9184** otherwise known as **"Government Procurement Reform Act and its Implementing Rules and Regulations"**;

WHEREAS, all bids were examined and found substantially complied with the technical and financial proposals, thereby making all bids passed the preliminary examination with their bid price as read shown hereunder;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on **August 19, 2021** hereby **RESOLVE**, as it is hereby **RESOLVED**:


a) To declare **MKA ENTERPRISES** with business address at **Feraren Hills Subd., Lumangbayan, Calapan City, Oriental Mindoro** as the bidder with **Single Calculated Responsive Bid**.

b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with **MKA ENTERPRISES** for **Supply & Delivery of Printing Services for use of PPDO re PDPFP Reproduction** at a contract price equivalent to **FOUR HUNDRED NINETY NINE THOUSAND FIFTY PESOS ONLY (Php 499,050.00)**.


