WHEREAS, in response to the said advertisement, one (1) prospective bidder purchased corresponding bid documents;


WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City at 2:00 p.m of October 14, 2021; the proceeding was in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations";

WHEREAS, all bids were examined and found substantially complied with the technical and financial proposals, thereby making all bids passed the preliminary examination with their bid price as read shown hereunder;

- a) To declare J A LHOUISSE ENTERPRISES with business address at Bonifacio St., Suqui, Calapan City, Oriental Mindoro as the bidder with Single Calculated Responsive Bid.
- b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter Into a contract with J A LHOUISSE ENTERPRISES for Supply & Delivery of Printing Services for use of Public Information Services Division-Office of the Governor in Information Dissemination re: 71st Founding Anniversary of Oriental Mindoro at a contract price equivalent to ONE HUNDRED NINETY SIX THOUSAND NINE HUNDRED PESOS ONLY (Php 196,900.00).
- c) To recommend to HUMERLITO A. DOLOR, MPA, PhD, Provincial Governor of Oriental Mindoro the approval of award and of contract to the bidder with Single Calculated Responsive Bid.
