WHEREAS, there is a purchase request submitted to the BAC for the procurement of Supply & Delivery of Veterinary Products and Supplies to be used by the Provincial Veterinary Office for the fourth quarter of 2021 at the Provincial Veterinary Learning and Extension Center in Calapan and Gloria;

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. GS-2021-144) in PhilGEPS Website on October 19, 2021 and posted in the Provincial Capitol Complex, Bulletin Board Camilmil, Calapan City on even date for the Supply & Delivery of Veterinary Products and Supplies to be used by the Provincial Veterinary Office for the fourth quarter of 2021 at the Provincial Veterinary Learning and Extension Center in Calapan and Gloria:

WHEREAS, in response to the said advertisement, one (1) prospective bidder purchased corresponding bid documents;

WHEREAS, the opening of bid v. neld at BAC Office, Provincial Capitol Complex, Calapan City at 2:00 p.m of October 26, 2021, the proceeding was in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations";

WHEREAS, all bids were examined and found substantially complied with the technical and financial proposals, thereby making all bids passed the preliminary examination with their bid price as read shown hereunder;

WHEREAS, the detailed evaluation and comparison of bids conducted on October 27, 2021 found out that bid price of MERAL ENTERPRISES is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the Single Calculated Responsive Bid;

WHEREAS, upon careful examination, validation and verification of eligibility, technical and financial requirements submitted MERAL ENTERPRISES with Single Calculated Responsive Bid, its bid passed the post qualification process conducted on November 3, 2021, thereby making its bid found to be responsive;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on November 4, 2021 hereby RESOLVE, as it is hereby RESOLVED:

- a) To declare MERAL ENTERPRISES with business address at Gen. Luna Street, Sabang, Lipa City, Batangas as the bidder with Single Calculated Responsive Bid.
- b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with MERAL ENTERPRISES for Supply & Delivery of Veterinary Products and Supplies to be used by the Provincial Veterinary Office for the fourth quarter of 2021 at the Provincial Veterinary Learning and Extension Center in Calapan and Gloria at a contract price equivalent to ONE HUNDRED SIXTY NINE THOUSAND NINE HUNDRED FORTY TWO PESOS ONLY (Php 169,942.00).
- c) To recommend to **HUMERLITO A. DOLOR, MPA, PhD**, Provincial Governor of Oriental Mindoro the approval of award and of contract to the bidder with **Single Calculated Responsive Bid**.
