WHEREAS, there is a purchase request submitted to the BAC for the procurement of Supply & Delivery of Information Technology Parts and Accessories & Perip for use of PEO Planning Services, Designing & Programming Services and Admin Services;

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee' advertised the Notice of Invitation to Bid (IB No. GS-2021-157) in PhilGEPS Website on November 11, 2021 and posted in the Provincial Capitol Complex, Bulletin Board Camilmil, Calapan City on even date for the Supply & Delivery of Information Technology Parts and Accessories & Perip for use of PEO Planning Services, Designing & Programming Services and Admin Services;

WHEREAS, in response to the said advertisement, one (1) prospective bidder purchased corresponding bid documents;

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City at 2:00 p.m of November 23, 2021, the proceeding was in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations";

WHEREAS, all bids were examined and found substantially complied with the technical and financial proposals, thereby making all bids passed the preliminary examination with their bid price as read shown hereunder;

WHEREAS, the detailed evaluation and comparison of bids conducted on November 23, 2021 found out that bid price of KIMLEN ENTERPRISES is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the Single Calculated Responsive Bid;

WHEREAS, upon careful examination, validation and verification of eligibility, technical and financial requirements submitted KIMLEN ENTERPRISES with Single Calculated Responsive Bid, its bid passed the post qualification process conducted on November 25, 2021, thereby making its bid found to be responsive;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on November 26, 2021 hereby RESOLVE, as it is hereby RESOLVED:

- a) To declare KIMLEN ENTERPRISES with business address at Calero, Calapan City, Oriental Mindoro as the bidder with Single Calculated Responsive Bid.
- b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with KIMLEN ENTERPRISES for Supply & Delivery of Information Technology Parts and Accessories & Perip for use of PEO Planning Services, Designing & Programming Services and Admin Services at a contract price equivalent to ONE HUNDRED FIFTY FIVE THOUSAND EIGHT HUNDRED FIFTY PESOS ONLY (Php 155,850.00).
- c) To recommend to **HUMERLITO A. DOLOR, MPA, PhD,** Provincial Governor of Oriental Mindoro the approval of award and of contract to the bidder with **Single Calculated Responsive Bid**.
