WHEREAS, there is a purchase request submitted to the BAC for the procurement of Supply & Delivery of Printing Services to be posted in different schools and barangays/municipalities as information, education campaign campaign of PDRRMO;

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. GS-2021-158) in PhilGEPS Website on November 11,—2021 and posted in the Provincial Capitol Complex, Bulletin Board Camilmil, Calapan City on even date for the Supply & Delivery of Printing Services to be posted in different schools and barangays/municipalities as information, education campaign campaign of PDRRMO;

WHEREAS, in response to the said advertisement, one (1) prospective bidder purchased corresponding bid documents;

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City at 2:00 p.m of November 23, 2021, the proceeding was in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations";

WHEREAS, all bids were examined and found substantially complied with the technical and financial proposals, thereby making all bids passed the preliminary examination with their bid price as read shown hereunder;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on November 26, 2021 hereby RESOLVE, as it is hereby RESOLVED:

- a) To declare J A LHOUISSE ENTERPRISES with business address at Bonifacio Street, Suqui, Calapan City, Oriental Mindoro as the bidder with Single Calculated Responsive Bid.
- b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with J A LHOUISSE ENTERPRISES for Supply & Delivery of Printing Services to be posted in different schools and barangays/municipalities as information, education campaign campaign of PDRRMO at a contract price equivalent to ONE HUNDRED SEVENTY THOUSAND FOUR HUNDRED THIRTY PESOS ONLY (Php 170,430.00).
- c) To recommend to HUMERLITO A. DOLOR, MPA, PhD, Provincial Governor of Oriental Mindoro the approval of award and of contract to the bidder with Single Calculated Responsive Bid.
