WHEREAS, there is a purchase request submitted to the BAC for the procurement of **Supply & Delivery of Office Supplies and Devices/Other Supplies for use of Half-way House for Former Rebel;**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. GS-2021-161) in PhilGEPS Website on **November 11, 2021** and posted in the Provincial Capitol Complex, Bulletin Board Camilmil, Calapan City on even date for the **Supply & Delivery of Office Supplies and Devices/Other Supplies for use of Half-way House for Former Rebel;**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder** purchased corresponding bid documents;

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City at **2:00 p.m of November 23, 2021**, the proceeding was in accordance with the provisions of **R.A. 9184** otherwise known as **"Government Procurement Reform Act and its Implementing Rules and Regulations"**;

WHEREAS, all bids were examined and found substantially complied with the technical and financial proposals, thereby making all bids passed the preliminary examination with their bid price as read shown hereunder;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on **November 26, 2021** hereby **RESOLVE**, as it is hereby **RESOLVED**:


a) To declare **LUCKY TYNES TRADING** with business address at **26 P. Urduja St. Doña Rosario Subd., Novaliches Quezon City** as the bidder with **Single Calculated Responsive Bid**.

b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with **LUCKY TYNES TRADING** for **Supply & Delivery of Office Supplies and Devices/Other Supplies for use of Half-way House for Former Rebel** at a contract price equivalent to **TWO HUNDRED FOURTEEN THOUSAND SIX HUNDRED SEVENTY TWO PESOS AND 30/100 (Php 214,672.30)**.

c) To recommend to **HUMERLITO A. DOLOR, MPA, PhD**, Provincial Governor of Oriental Mindoro the approval of award and of contract to the bidder with **Single Calculated Responsive Bid**.
