WHEREAS, there is a purchase request submitted to the BAC for the procurement of Supply & Delivery of Chemicals and Chemical Products for OMSDH patients use;

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. GS-2021-162) in PhilGEPS Website on November 25, 2021 and posted in the Provincial Capitol Complex, Bulletin Board Camilmil, Calapan City on even date for the Supply & Delivery of Chemicals and Chemical Products for OMSDH patients use;

WHEREAS, in response to the said advertisement, one (1) prospective bidder purchased corresponding bid documents;

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City at 2:00 p.m of December 2, 2021, the proceeding was in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations";

WHEREAS, all bids were examined and found substantially complied with the technical and financial proposals, thereby making all bids passed the preliminary examination with their bid price as read shown hereunder:

WHEREAS, the detailed evaluation and comparison of bids conducted on **December 3, 2021** found out that bid price of **CALOOCAN GAS CORPORATION** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Responsive Bid**;

WHEREAS, upon careful examination, validation and verification of eligibility, technical and financial requirements submitted CALOOCAN GAS CORPORATION with Single Calculated Responsive Bid, its bid passed the post qualification process conducted on December 10, 2021, thereby making its bid found to be responsive;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on December 13, 2021 hereby RESOLVE, as it is hereby RESOLVED:

- a) To declare CALOOCAN GAS CORPORATION with business address at Industrial Subd., Golden Rd. Street, Caloocan City as the bidder with Single Calculated Responsive Bid.
- b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with CALOOCAN GAS CORPORATION for Supply & Delivery of Chemicals and Chemical Products for OMSDH patients use at a contract price equivalent to FIVE HUNDRED FIFTY THOUSAND PESOS ONLY (Php 550,000.00).
- c) To recommend to **HUMERLITO A. DOLOR, MPA, PhD,** Provincial Governor of Oriental Mindoro the approval of award and of contract to the bidder with **Single Calculated Responsive Bid**.
