1. The Provincial Government of Oriental Mindoro (PGOM) through the General Fund intends to apply Six Hundred Seventeen Thousand One Hundred Thirty Two Pesos Only (Php 617,132.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Project, "Supply and Delivery of Vehicle Parts and Accessories for use of RG#08, KOMATSU GD511A and RG #09, CHAMPION 710A." Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PGOM now invites bids for the Project, "Supply and Delivery of Vehicle Parts and Accessories for use of RG#08, KOMATSU GD511A and RG #09, CHAMPION 710A." Delivery of the goods shall be in accordance with the Delivery Schedule under Section VI. Schedule of Requirements. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least twenty five percent (25%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidder (ITB).

Bidding is restricted to Filipino citizens/sole proprietorship, partnership or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of w/c grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

6. The PGOM reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
