WHEREAS, there is a purchase request submitted to the BAC for the procurement of **Supply & Delivery of Photographic Parts, Supplies & Accessories for the use of Sangguniang Panlalawigan** ;

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. GS-2021-166) in PhilGEPS Website on **December 2, 2021** and posted in the Provincial Capitol Complex, Bulletin Board Camilmil, Calapan City on even date for the **Supply & Delivery of Photographic Parts, Supplies & Accessories for the use of Sangguniang Panlalawigan**;

WHEREAS, in response to the said advertisement, **one (1) prospective bidder** purchased corresponding bid documents;

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City at **2:00 p.m of December 9, 2021**, the proceeding was in accordance with the provisions of **R.A. 9184** otherwise known as **"Government Procurement Reform Act and its Implementing Rules and Regulations"**;

WHEREAS, all bids were examined and found substantially complied with the technical and financial proposals, thereby making all bids passed the preliminary examination with their bid price as read shown hereunder;

WHEREAS, the detailed evaluation and comparison of bids conducted on **December 09, 2021** found that the bid price of **KIMLEN ENTERPRISES** is deemed the most advantageous to the government, no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Responsive Bid**;

WHEREAS, upon careful examination, validation and verification of eligibility, technical and financial requirements submitted by **KIMLEN ENTERPRISES** with **Single Calculated Responsive Bid**, its bid passed the post qualification process conducted on **December 13, 2021**, thereby making its bid responsive;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, in our meeting on **December 14, 2021** hereby **RESOLVE**, as it is hereby **RESOLVED**:


a) To declare **KIMLEN ENTERPRISES** with business address at **Calero Calapan City Oriental Mindoro** as the bidder with the **Single Calculated Responsive Bid**.

b) To recommend that the Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with **KIMLEN ENTERPRISES** for the **Supply & Delivery of Photographic Parts, Supplies & Accessories for the use of Sangguniang Panlalawigan** at a contract price equivalent to **FIVE HUNDRED EIGHTY ONE THOUSAND NINE HUNDRED TWENTY ONE PESOS ONLY (Php 581,921.00)**; and

c) To recommend to **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor of Oriental Mindoro the approval of the award and contract to the bidder with the **Single Calculated Responsive Bid**.
