WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. GS-2021-172) in PhilGEPS Website on December 2, 2021 and posted in the Provincial Capitol Complex, Bulletin Board Camilmil, Calapan City on even date for the Supply & Delivery of Chemicals and Chemical Products for use of the OMPH Patients;

WHEREAS, in response to the said advertisement, one (1) prospective bidder purchased corresponding bid documents;

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City at 10:00 a.m of December 9, 2021, the proceeding was in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations";

WHEREAS, all bids were examined and found substantially complied with the technical and financial proposals, thereby making all bids passed the preliminary examination with their bid price as read shown hereunder;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, in our meeting on December 20, 2021 hereby RESOLVE, as it is hereby RESOLVED:

- a) To declare SOUTHERN GAS CORPORATION with business address at Comunal Calapan City Oriental Mindoro as the bidder with the Single Calculated Responsive Bid.
- b) To recommend that the Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with SOUTHERN GAS CORPORATION for the Supply & Delivery of Chemicals and Chemical Products for use of the OMPH Patients at a contract price equivalent to SEVEN HUNDRED THIRTY SEVEN THOUSAND FIVE HUNDRED THIRTY PESOS ONLY (Php 737,530.00); and
  - c) To recommend to **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor of Oriental Mindoro the approval of the award and contract to the bidder with the **Single Calculated Responsive Bid**.
