INVITATION TO BID IB NO. CW 2021 - 513

Construction of Legislative Building at Poblacion, San Teodoro, Oriental Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the General Fund 2021 intends to apply the sum of One Million Nine Hundred Ninety Nine Thousand Eighty Seven Pesos and 94/100 Only (Php 1,999,087.94) being the approved Budget for the Contract (ABC) to payment under the contract for "Construction of Legislative Building at Poblacion, San Teodoro, Oriental Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Construction of Legislative Building at Poblacion, San Teodoro, Oriental Mindoro". Completion of the Works is 56 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Bid opening shall be on November 19, 2021 at 9:00 a.m. at BAC Conference Room, Provincial Capitol Complex, Camilmil, Calapan City, Oriental Mindoro. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address stated. Late bids shall not be accepted.

BAC RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT (INFRASTRUCTURE)

Resolution No. 523, Series of 2021

WHEREAS, there is an infrastructure project funded through the General Fund 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the Construction of Legislative Building at Poblacion, San Teodoro, Oriental Mindoro (Construction of 12 x 9.8m Legislative Building at Poblacion. First floor only w/o tileworks, painting and septic tank);

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-513) in PhilGEPS Website on October 29, 2021 and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the Construction of Legislative Building at Poblacion, San Teodoro, Oriental Mindoro (Construction of 12 x 9.8m Legislative Building at Poblacion. First floor only w/o tileworks, painting and septic tank);

WHEREAS, in response to the said advertisement, two (2) prospective bidders/contractors submitted application for eligibility and purchased bid documents;

- 1. GEMWEALTH CONSTRUCTION AND TRADING CORPORATION
- 2. MDH CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on November 19, 2021, the bids were received until 8:30 am and opened thereafter in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations":

WHEREAS, during the opening of Bid on November 19, 2021 eligibility check was conducted to two (2) bidders/contractors mentioned above and were found eligible by the BAC;

WHEREAS, all bid proposals submitted during the opening of bid were examined and found substantially complied with the technical and financial proposals, thereby making all bid proposals passed the preliminary examination of bid as their corresponding bid price read out as follows.

WHEREAS, the detailed evaluation and comparison of bids conducted on November 19, 2021 found out that bid price of GEMWEALTH CONSTRUCTION AND TRADING CORPORATION is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the Lowest Calculated Bid:

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by GEMWEALTH CONSTRUCTION AND TRADING CORPORATION with Lowest Calculated Bid, its bid passed the post qualification process conducted on November 23, 2021, thereby making its bid found to be responsive;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on November 29, 2021 hereby RESOLVE, as it is hereby RESOLVED:

- a) To declare **GEMWEALTH CONSTRUCTION AND TRADING CORPORATION** with business address at **Lapu-lapu**, **Ibaan**, **Batangas** as the bidder with **Lowest Calculated Responsive Bid**.
- b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with GEMWEALTH CONSTRUCTION AND TRADING CORPORATION for the Construction of Legislative Building at Poblacion, San Teodoro, Oriental Mindoro (Construction of 12 x 9.8m Legislative Building at Poblacion. First floor only w/o tileworks, painting and septic tank) at a contract price equivalent to ONE MILLION NINE HUNDRED NINETY SIX THOUSAND EIGHTY EIGHT PESOS AND 82/100 ONLY (Php 1,996,088.82).
- c) To recommend to **HUMERLITO A. DOLOR**, Provincial Governor of Oriental Mindoro the approval of award and of contract to the bidder with Lowest Calculated Responsive Bid.
