WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-452-A) in PhilGEPS Website on **November 10, 2021** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Reblocking of Road at San Vicente South, Calapan City, Oriental Mindoro (Concreting of Road: PCCP1: L of PCCP=42.00m, W of PCCP=2.00m(ave.), T of PCCP=0.15m, Thk 201=0.15m; PCCP2: L of PCCP=22.00m, W of PCCP=2.50m, T of PCCP=0.15m, Thk 201=0.15m; PCCP3: L of PCCP=10.00m, W of PCCP=2.00m, T of PCCP=0.15m, Thk 201=0.15m; PCCP4: L of PCCP=21.00m, W of PCCP=1.50m(ave.), T of PCCP=0.15m, Thk 201=0.15m; PCCP5: L of PCCP=11.50m, W of PCCP=4.00m, T of PCCP=0.15m, Thk 201=0.15m; PCCP6: L of PCCP=54.00m, W of PCCP=4.00m, T of PCCP=0.15m, Thk 201=0.15m; Total Length=160.50m);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. SGDG CONSTRUCTION AND SUPPLIES

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **November 19, 2021**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **November 19, 2021** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **SGDG CONSTRUCTION AND SUPPLIES** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **November 19, 2021** found out that bid price of **SGDG CONSTRUCTION AND SUPPLIES** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **SGDG CONSTRUCTION AND SUPPLIES** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **November 23, 2021**, thereby making its bid found to be responsive;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on **November 29, 2021** hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare **SGDG CONSTRUCTION AND SUPPLIES** with business address at **Sapul, Calapan City, Oriental Mindoro** as the bidder with **Single Calculated Responsive Bid**.
