**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

Resolution No. 521, Series of 2021

WHEREAS, there is an infrastructure project funded through the **20% Development Fund 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Seawall at Maasin, Bulalacao, Oriental Mindoro (Construction of Seawall: L=25.00m)**;

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-511) in PhilGEPS Website on **October 29, 2021** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Construction of Seawall at Maasin, Bulalacao, Oriental Mindoro (Construction of Seawall: L=25.00m)**;

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. 811 TRADING AND CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **November 19, 2021**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **November 19, 2021** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **811 TRADING AND CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **November 19, 2021** found out that bid price of **811 TRADING AND CONSTRUCTION** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **811 TRADING AND CONSTRUCTION** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **November 23, 2021**, thereby making its bid found to be responsive;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on **November 29, 2021** hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare **811 TRADING AND CONSTRUCTION** with business address at **9 Palayan St., Paclasan, Roxas, Oriental Mindoro** as the bidder with **Single Calculated Responsive Bid**.
- b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with **811 TRADING AND CONSTRUCTION** for the **Construction of Seawall at Maasin, Bulalacao, Oriental Mindoro (Construction of Seawall: L=25.00m)** at a contract price equivalent to **ONE MILLION FOUR HUNDRED NINETY ONE THOUSAND EIGHT HUNDRED THIRTY THREE PESOS ONLY (Php 1,491,833.00)**.
- c) To recommend to **HUMERLITO A. DOLOR**, Provincial Governor of Oriental Mindoro the approval of award and of contract to the bidder with Single Calculated Responsive Bid.
