**Improvement of Roxas Town Plaza, Roxas, Oriental Mindoro**

1. The Provincial Government of Oriental Mindoro (PGOM) through the General Fund 2021 intends to apply the sum of **Four Million Nine Hundred Seventy Five Thousand Eight Hundred Fifty Pesos and 46/100 Only (Php 4,975,850.46)** being the approved Budget for the Contract (ABC) to payment under the contract for **"Improvement of Roxas Town Plaza, Roxas, Oriental Mindoro"**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PGOM now invites bids for **"Improvement of Roxas Town Plaza, Roxas, Oriental Mindoro"**. Completion of the Works is **102 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

**WHEREAS**, there is an infrastructure project funded through the **General Fund 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Improvement of Roxas Town Plaza, Roxas, Oriental Mindoro (Construction of Roxas Grandstand; Dimension: (16m x 10.85m); SOURCE (sand & gravel): Orcunoma River)**;

**WHEREAS**, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-518) in PhilGEPS Website on **October 29, 2021** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Improvement of Roxas Town Plaza, Roxas, Oriental Mindoro (Construction of Roxas Grandstand; Dimension: (16m x 10.85m); SOURCE (sand & gravel): Orcunoma River)**;

**WHEREAS**, in response to the said advertisement, **two (2) prospective bidders/contractors** submitted application for eligibility and purchased bid documents;

- 1. WEBUILD CONSTRUCTION**
- 2. MDH CONSTRUCTION**

**WHEREAS**, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **November 19, 2021**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

**WHEREAS**, during the opening of Bid on **November 19, 2021** eligibility check was conducted to two (2) bidders/contractors mentioned above and were found eligible by the BAC;

**WHEREAS**, all bid proposals submitted during the opening of bid were examined and found substantially complied with the technical and financial proposals, thereby making all bid proposals passed the preliminary examination of bid as their corresponding bid price read out as follows.

**NOW, THEREFORE**, We the Members of the Bids and Awards Committee, in our meeting on **November 29, 2021** hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare **WEBUILD CONSTRUCTION** with business address at **Bagumbayan, Roxas, Oriental Mindoro** as the bidder with **Lowest Calculated Responsive Bid**.


