Repair of Covered Court at Fe Del Mundo High School, B. del Mundo, Mansalay, Or. Mindoro

1. The Provincial Government of Oriental Mindoro (PGOM) through the LGSF – DRRP Fund 2021 intends to apply the sum of **Nine Hundred Sixty Six Thousand Nine Hundred Seventy Two Pesos and 32/100 Only (Php 966,972.32)** being the approved Budget for the Contract (ABC) to payment under the contract for **"Repair of Covered Court at Fe Del Mundo High School, B. del Mundo, Mansalay, Or. Mindoro"**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PGOM now invites bids for **"Repair of Covered Court at Fe Del Mundo High School, B. del Mundo, Mansalay, Or. Mindoro"**. Completion of the Works is **37 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

WHEREAS, there is an infrastructure project funded through the **LGSF-DRRP Fund 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Repair of Covered Court at Fe Del Mundo High School, B. Del Mundo, Mansalay, Oriental Mindoro (Construction of 1 span Covered Court 5m x 16m dimension w/ installation of roof, roof framing and roof accessories; construction of Columns and beams; Painting of All Columns & Beams);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-535) in PhilGEPS Website on **November 20, 2021** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Repair of Covered Court at Fe Del Mundo High School, B. Del Mundo, Mansalay, Oriental Mindoro (Construction of 1 span Covered Court 5m x 16m dimension w/ installation of roof, roof framing and roof accessories; construction of Columns and beams; Painting of All Columns & Beams);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. 811 TRADING AND CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **November 29, 2021**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **November 29, 2021** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **811 TRADING AND CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on **December 09, 2021** hereby **RESOLVE**, as it is hereby **RESOLVED**:


