**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

Resolution No. 538, Series of 2021

WHEREAS, there is an infrastructure project funded through the **LGSF – DRRP Fund 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Roofing of Barangay Hall at Magtibay, Naujan, Oriental Mindoro (Replacement of roof (including porch), electrical, windows and some doors. Re-painting of whole building. Tiles at CR only. Installation of ceiling (inside & outside);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-536) in PhilGEPS Website on **November 20, 2021** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Roofing of Barangay Hall at Magtibay, Naujan, Oriental Mindoro (Replacement of roof (including porch), electrical, windows and some doors. Re-painting of whole building. Tiles at CR only. Installation of ceiling (inside & outside);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. RADEL CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **November 29, 2021**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **November 29, 2021** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **RADEL CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **November 29, 2021** found out that bid price of **RADEL CONSTRUCTION** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **RADEL CONSTRUCTION** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **December 02, 2021**, thereby making its bid found to be responsive;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on **December 09, 2021** hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare **RADEL CONSTRUCTION** with business address at **Along C-5 Road, Sta. Isabel, Calapan City, Oriental Mindoro** as the bidder with **Single Calculated Responsive Bid**.
- b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with **RADEL CONSTRUCTION** for the **Roofing of Barangay Hall at Magtibay, Naujan, Oriental Mindoro (Replacement of roof (including porch), electrical, windows and some doors. Re-painting of whole building. Tiles at CR only. Installation of ceiling (inside & outside)** at a contract price equivalent to **FIVE HUNDRED NINETY EIGHT THOUSAND EIGHT HUNDRED SEVENTY SIX PESOS AND 17/100 ONLY (Php 598,876.17)**.
- c) To recommend to **HUMERLITO A. DOLOR**, Provincial Governor of Oriental Mindoro the approval of award and of contract to the bidder with Single Calculated Responsive Bid.

1. The Provincial Government of Oriental Mindoro (PGOM) through the LGSF – DRRP Fund 2021 intends to apply the sum of **Five Hundred Ninety Nine Thousand Nine Hundred Sixteen Pesos and 54/100 Only (Php 599,916.54)** being the approved Budget for the Contract (ABC) to payment under the contract for **"Roofing of Barangay Hall at Magtibay, Naujan, Or. Mindoro"**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PGOM now invites bids for **"Roofing of Barangay Hall at Magtibay, Naujan, Or. Mindoro"**. Completion of the Works is **35 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
