**Rehabilitation of Drainage Canal at Suqui, Calapan City, Or. Mindoro**

1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% Development Fund 2021 intends to apply the sum of **Nine Hundred Ninety Six Thousand Nine Hundred Eighty Nine Pesos and 16/100 Only (Php 996,989.16)** being the approved Budget for the Contract (ABC) to payment under the contract for **"Rehabilitation of Drainage Canal at Suqui, Calapan City, Or. Mindoro"**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PGOM now invites bids for **"Rehabilitation of Drainage Canal at Suqui, Calapan City, Or. Mindoro"**. Completion of the Works is **30 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

8. The PGOM reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.

RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT

**Resolution No. 540, Series of 2021**

**WHEREAS**, there is an infrastructure project funded through the **20% Development Fund 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Rehabilitation of Drainage Canal at Suqui, Calapan City, Oriental Mindoro (Construction of Canals: Source of Aggregate=Tigkan River; Rehabilitation of Drainage Canal: Canal Length=142.00m, Depth=1.00m, Inside Width=0.80m, Construction of Canal Cover Length=152.00m, Note: Canal Total Length(existing): 1167.00m);**

**WHEREAS**, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-538) in PhilGEPS Website on **November 20, 2021** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Rehabilitation of Drainage Canal at Suqui, Calapan City, Oriental Mindoro (Construction of Canals: Source of Aggregate=Tigkan River; Rehabilitation of Drainage Canal: Canal Length=142.00m, Depth=1.00m, Inside Width=0.80m, Construction of Canal Cover Length=152.00m, Note: Canal Total Length(existing): 1167.00m);**

**WHEREAS**, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

**1. LAS MINAS DE ORO CONSTRUCTION**

**WHEREAS**, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **November 29, 2021**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

**WHEREAS**, during the opening of Bid on **November 29, 2021** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

**WHEREAS**, the bid proposals submitted by **LAS MINAS DE ORO CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

**WHEREAS**, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **LAS MINAS DE ORO CONSTRUCTION** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **December 02, 2021**, thereby making its bid found to be responsive;

**NOW, THEREFORE**, We the Members of the Bids and Awards Committee, in our meeting on **December 09, 2021** hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare **LAS MINAS DE ORO CONSTRUCTION** with business address at **Sta. Maria Village, Calapan City, Oriental Mindoro** as the bidder with **Single Calculated Responsive Bid**.
- b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with **LAS MINAS DE ORO CONSTRUCTION** for the **Rehabilitation of Drainage Canal at Suqui, Calapan City, Oriental Mindoro (Construction of Canals: Source of Aggregate=Tigkan River; Rehabilitation of Drainage Canal: Canal Length=142.00m, Depth=1.00m, Inside Width=0.80m, Construction of Canal Cover Length=152.00m, Note: Canal Total Length(existing): 1167.00m)** at a contract price equivalent to **NINE HUNDRED NINETY FOUR THOUSAND NINE HUNDRED THIRTY FIVE PESOS AND 39/100 ONLY (Php 994,935.39)**.
