

RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the **Special Education Fund 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Installation of Water System to the Newly Constructed Building at Leuteboro NHS, Socorro, Oriental Mindoro (Construction of concrete elevated water tank, 2.7m x 2.7m x 2m w/ HDPE pipe and 2 HP electric water pump; 1 HP electric water pump and power house);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-555) in PhilGEPS Website on **November 20, 2021** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Installation of Water System to the Newly Constructed Building at Leuteboro NHS, Socorro, Oriental Mindoro (Construction of concrete elevated water tank, 2.7m x 2.7m x 2m w/ HDPE pipe and 2 HP electric water pump; 1 HP electric water pump and power house);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. SOSEP BUILDERS

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **November 29, 2021**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **November 29, 2021** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **SOSEP BUILDERS** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **November 29, 2021** found out that bid price of **SOSEP BUILDERS** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;

WHEREAS, upon careful examination, validation and verification of eligibility, technical, financial requirements submitted by **SOSEP BUILDERS** with **Single Calculated Bid**, its bid passed the post qualification process conducted on **December 02, 2021**, thereby making its bid found to be responsive;

NOW, THEREFORE, We the Members of the Bids and Awards Committee, in our meeting on **December 09, 2021** hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare **SOSEP BUILDERS** with business address at **Campaasan, Bulalacao, Oriental Mindoro** as the bidder with **Single Calculated Responsive Bid**.
- b) To recommend that Provincial Government of Oriental Mindoro represented by the Provincial Governor enter into a contract with **SOSEP BUILDERS** for the **Installation of Water System to the Newly Constructed Building at Leuteboro NHS, Socorro, Oriental Mindoro (Construction of concrete elevated water tank, 2.7m x 2.7m x 2m w/ HDPE pipe and 2 HP electric water pump; 1 HP electric water pump and power house)** at a contract price equivalent to **EIGHT HUNDRED TWENTY ONE THOUSAND ONE HUNDRED EIGHTY TWO PESOS AND 66/100 ONLY (Php 821,182.66)**.

1. The Provincial Government of Oriental Mindoro (PGOM) through the Special Education Fund 2021 intends to apply the sum of **Eight Hundred Twenty Three Thousand Sixty One Pesos and 70/100 Only (Php 823,061.70)** being the approved Budget for the Contract (ABC) to payment under the contract for **"Installation of Water System to the Newly Constructed Building at Leuteboro NHS, Socorro, Or. Mindoro"**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PGOM now invites bids for **"Installation of Water System to the Newly Constructed Building at Leuteboro NHS, Socorro, Or. Mindoro"**. Completion of the Works is **54 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bid opening shall be on **November 29 2021 at 9:00 a.m. at BAC Conference Room, Provincial Capitol Complex, Camimil, Calapan City, Oriental Mindoro.** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address stated. Late bids shall not be accepted.

7. The PGOM reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
